## **ORDERING A PHOTO REPRODUCTION**

To request an image reproduction, complete the order form in this document. If the image will be used for any purpose other than personal use, complete the **Letter of Agreement for Reproduction**. The agreement must be completed and signed by the person requesting the image for reproduction. The person signing the agreement is responsible for conforming to the **Conditions for Reproduction**. The Letter of Agreement for Reproduction acts as the contract and invoice. The Museum representative will countersign the form. The form will be returned, signifying that use as stated on the form has been granted. Include all use fees on the order form.

Institutions and businesses may be billed. Please include Federal or State tax-exempt identification number.

Publishers shall furnish the City of Las Vegas Museum without charge one copy of each publication in which a reproduction is used.

Payment must be made in US dollars. Checks should be made payable to City of Las Vegas Museum.
